Karen suggested having the shady ladies lifted again but this time they need to be lifted higher. This will help with the grass growth under the trees. Brian will contact the tree trimmer.

Karen stated that new plants will need to be installed behind 1136.

Martha asked Dana if he would like to be the on site point of contact for Brightview. Dana accepted the position. Dana will recommend any new planting to the Board for approval.
