Martha suggested getting an arborist to design a landscape plan for the front wall and entrance. Dana wants to schedule a walk through with Twin Palm to make sure the pruning will be done correctly and what the Board wants.

Dana stated that Twin Palm is doing a good job with the roundup on the hard surfaces.
